ARTICLES OF INCORPORATION

OF

MANILA JOCKEY CLUB, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, residents of the Philippines, have voluntarily associated ourselves for the purpose of forming a corporation under the Laws of the Commonwealth.

AND BY THESE PRESENTS CERTIFY --

First. - That the name of said corporation shall be the MANILA JOCKEY CLUB, INC.

Second. -- That, the purposes for which the corporation is formed are:

PRIMARY --

To conduct horse races and to develop horse race tracks in the San Lazaro Hippodrome in Manila, in Bulacan, and in such other places authorized by law. (As amended March 8, 1977).

SECONDARY --

- 1. To acquire real properties, to construct buildings on the same for 2.9 Am the purpose of leasing them, and to sell them if, in the opinion of the Board of Directors, the sale is advantageous.
 - To purchase and to sell shares of stock of other corporations.

www self. To engage in all kinds of lawful recreations for the members such Secocs11 as, for example, establishing bowling alkeys, tennis courts, billiard halfs, and other

- To deal in, in order to carry into effect the business of the company in general, the importation and exportation of goods and merchandise of any kind.
- To do and any and everything necessary, proper, suitable or convenient for the attainment of the corporate purpose and objectives and the furtherance of the powers set forth herein, and to do and carry out all acts and things growing out of or connected with the aforesaid powers insofar as the same are permitted by (or not inconsistent with) the laws of the Philippines.
- To engage in the business to develop real estate properties into mix-use real estate development projects including but not limited to leisure, recreational and memorial parks, operate, manage and/or sell the real estate development projects.

In order to achieve the expressed objectives, the corporation shall construct buildings and other kinds of improvements in the mentioned hippodrome and on the other properties that will be acquired, and to lease other real properties.


