Nature and description of the legal proceedings

The Philippine Racing Commission asserts control over the disposition of unclaimed dividends. On November 7, 2013, MJCI filed a Petition for Declaratory Relief before the Regional Trial Court of Bacoor, Cavite. MJCI maintains that there is no law authorizing the Philippine Racing Commission, the Games and Amusement Board, and any other government agency to control the disposition of unclaimed dividends, and that the same forms part of MJCI's private funds.

Other Relevant Information

Unclaimed dividends are dividends from winning tickets which are not claimed by the holders thereof. It is stipulated in the betting tickets of MJCI that winning tickets must be claimed within 30 days from date of purchase. Otherwise, prize thereof shall be forfeited in favor of MJCI.
