Item 9. Other Events

At the regular meeting of the Board of Directors of Manila Jockey Club, Inc. (the "Company") held on September 11, 2018 at 12th Floor, Strata 100 Building, F. Ortigas, Jr. Road, Ortigas Center, Pasig City, the Board approved the following:

- (1) Increase of the Company's authorized capital stock from One Billion Pesos (Php1,000,000,000.00) divided into One Billion (1,000,000,000) shares with a par value of One Peso (Php1.00) per share to Two Billion Pesos (Php2,000,000,000,000) divided into Two Billion (2,000,000,000) shares with a par value of One Peso (Php1.00) per share; and
- (2) Declaration of 50% stock dividends from the Company's unrestricted retained earnings for the period ended 31 December 2017, to cover the minimum subscription and payment for the increase in the authorized capital stock.

The foregoing shall be submitted for the approval of the Company's stockholders at a special stockholders' meeting to be announced by the Company.
