I. Special Stockholders' Meeting

At the Special Stockholders' Meeting of Manila Jockey Club, Inc. (the "Company") held on December 7, 2018 at the San Lazaro Leisure and Business Park, the stockholders of the Company approved the following:

- (1) Declaration of 50% stock dividends out of the Company's unrestricted retained earnings for the period ended 31 December 2017, to be taken from an increase in the authorized capital stock of the Company; and
- (2) Increase of the Company's authorized capital stock from One Billion Pesos (Php1,000,000,000.00) divided into One Billion (1,000,000,000) shares with a par value of One Peso (Php1.00) per share to Two Billion Pesos (Php2,000,000,000.00) divided into Two Billion (2,000,000,000) shares with a par value of One Peso (Php1.00) per share.
